ZEF extends capacity building activities in Ghana

The Ghanaian-German Center for Development Studies (GGCDS) at the University of Ghana, which was established by ZEF in collaboration with the Institute of Statistical Social and Economic Research (ISSER) in 2008, will receive funding for another five years (2014-2018) from its donors, the German Ministry for Foreign Affairs and the German Academic Exchange Service (DAAD). In the upcoming second phase, the project will reach out to the University of Development Studies (UDS) in northern Ghana and sponsor a total of 35 additional PhD candidates. In the first phase of the project, 23 students have been sponsored, of whom five completed their doctoral studies.

New research projects

ZEF continues to be successful in acquiring new research projects and extending existing ones. Here are the major achievements in 2014:

- A new program for innovation in food security and agriculture in Africa and India. It is based on a scientific and institutional consultation network of a consortium led by ZEF with African partners. Funds will be provided for three years by the Ministry for Economic Cooperation and Development (BMZ).
- A research project on the nexus of energy, water and food along the Nile Basin (Ethiopia, Sudan, Egypt) with research partners in the region and IFPRI.
- A research project on bio-economy and land use in Brazil in cooperation with the Center for International Forestry Research (CIFOR).
- A research project on integrated management of citrus pests and diseases in East Africa with icipe, the International Centre of Insect Physiology and Ecology in Nairobi (see: <u>ZEF Website</u>).
- "HEALTHCAP". ZEF launched this new research initiative in Uzbekistan in April 2014 to strengthen science-based capacities for improving public health systems and risk assessment strategies in Uzbekistan. The project will apply disciplinary and interdisciplinary research tools and analyze the role that agriculture and urbanization play with regard to water-related diseases in two case study regions. - Extension of the competence network Crossroads Asia focusing on mobility/immobility patterns and border/boundary negotiations, questioning the conventional world regions of Central and South Asia. The network brings together seven institutional partners in Germany. The scientific coordination and head office is located at ZEF. See http://crossroads-asia.de
- A new inter-university collaboration with the University of Cochabamba on biodiversity conservation.
- A new research and capacity building initiative, together with UNU in Bonn and the Cologne University of Applied Sciences, to support the Pan African Universities Institute of Water and Energy Sciences (PAUWES) at Tlemcen in Algeria. See <u>ZEF Website</u>.

Awards for ZEF doctoral students and alumni

Abu Hayat Md Saiful Islam, ZEF junior researcher from Bangladesh, received the "Young Rice Scientist Award" for his paper on "Impact of integrated aquaculture-agriculture technologies value chain participation on welfare of marginalized indigenous households in Bangladesh: a panel data analysis". The



prize was awarded on the occasion of the International Rice Congress (IRC) 2014 in Bangkok, Thailand, October 27 – November 1.

Sonam Tashi, ZEF junior researcher from Bhutan, was nominated by the Regional Office New Delhi of the



German Academic Exchange Service (DAAD) as a Research Ambassador for his country. DAAD Research Ambassadors are partners in pursuit of excellence by being a reliable and trustworthy source of information on education and

research. They are the first point of contact for academic cooperation and projects, planning visits of high-level delegations from Germany as well as role-models for the next generation of students and scholars. DAAD Research Ambassador is an honorary position with a three-year tenure. In his new capacity as a DAAD Ambassador, Sonam Tashi has been invited to attend an orientation workshop for Research Ambassadors scheduled for November 14-16, 2014 in New Delhi.

Justice Nana Inkoom, ZEF doctoral student from Ghana working with the WASCAL program, was awarded a prize for his abstract on "Impact of the spatial arrangement of agricultural land use on ecosystems services and periurban livelihoods at the landscape scale", submitted to this year's American Geophysical Union (AGU) Fall Meeting, to be held in San Francisco from December 15-19. The prize consists of a travel grant of 1,000 USD which enables Justice Nana to attend the meeting.

Francis Molua Mwambo, ZEF junior researcher from Ghana, was awarded the prize for the best paper presented at a conference on "Ethics of Food Security in a Changing Society – Learning from the Past to Shape the Future" in Cumberland Lodge, United Kingdom, September 24. The paper was entitled "Assessing the ecological-societal impacts of West African farming practices by means of energy efficiency".

Willis Okumu, ZEF junior researcher from Kenya, was nominated for the African Good Governance Network (AGGN) of DAAD. AGGN comprises a group of highly educated African academics who are currently studying in Germany or have done so in the past. Due to their qualifications they are expected to be among the future decision makers dedicated to Good Governance principles in sub-Saharan Africa.

Sayan Chakrabarty, ZEF alumnus from Bangladesh, has received the "USQ Publication Excellence Award 2013" of the University of Southern Queensland for his publication. As a Postdoctoral Research Fellow he is in charge of the research project "Use of Technology in Higher Education: An Assessment from Socio-Economic Perspectives ".

Alumni at conferences and workshops

Benjamin Kofi Nyarko (ZEFc, Ghana, Batch 2003), who works at the Department of Geography and Regional Planning at the University of Cape Coast (Ghana), participated in a workshop on "Reintegration into the domestic job market" in Bonn from June 20-24, 2014 and gave a presentation on this topic. Anastasiya Shtaltovna (ZEFa senior researcher, Ukraine, Batch 2008) organized the Follow the Innovation (FTI) training of facilitators in Addis Ababa, Ethiopia and gave a keynote speech at the workshop of the Regional Programme for Sustainable Use of Natural Resources in Central Asia in Avaza, Turkmenistan, on September 29 - October 3.

The third World Congress on Agroforestry, organized by the World Agroforestry Centre, the Indian Council of Agricultural Research, the Indian Society of Agroforestry, and Global Initiatives, took place in Delhi, India, on February 10-14.
