AUTHORISATION FOR DATA PROCESSING

The undersigned certifies that the information provided is correct and can be processed.

Pursuant to article 7 and 13 of legislative decree no. 196/2003 ("Codice in materia di protezione dei dati personali") setting out provisions on the protection of personal data with regards to the confidentiality of their personal information, it is notified that:

- 1. Personal information requested or acquired, information relative to the academic career or produced by the University of Trento in pursuit of its institutional functions, as well as information deriving from the electronic processing thereof, may be collected, handled and disclosed both during the academic career of the person concerned and subsequently to it to external bodies for purposes pertaining to the University's institutional activities.
- 2. Conferral of personal data as at point 1 is compulsory.
- 3. For the same purposes as stated at point 1, personal data may be disclosed to other public bodies and associations, even located outside the national territory, but such disclosure must concern solely the organization of work experience initiatives (stages and placements) and postgraduate training.
- 4. Data are handled by manual and electronic devices intended for the purpose and in a manner such to guarantee their confidentiality.
- 5. Article 7 of the decree law entitles those concerned to have their data made available in intelligible form and that they will be updated, amended and supplemented. Those concerned may also request estoppels on data handled in breach of the Law.
- 6. The data handling agent is the University of Trento, with offices in Via Belenzani, 12.
